The CoC followed its publicly posted reallocation protocol that states that a project may be subjected to reallocation if the project has fallen in the bottom 10% of project performance as evidenced by the CoC Ranking during the local competition. The OCO PSH HOPE Program project had consistently fallen into the bottom 10% since it was first funded and was brought to the review committee for reallocation decision. The committee, made up of non-ESG and non-CoC funded members of the CoC Advisory Board determined that the project met the criteria for reallocation and that the project would again fall into the bottom 10% in this year's competition. The Committee voted by over a 3/4 to reallocate the project. The project was notified of the reallocation on Friday, August 12, 2022.


